A Letter from the Chief of Police and Board Chair

Throughout 2023, the Guelph Police Service continued to focus on key priorities including: community policing; organizational health and service effectiveness; community safety and wellness; road safety; drugs and property crime; and the downtown.

2023 saw the culmination of the Service's 2018-2023 "Moving Forward Together" Strategic Plan. Together with our community, we have been planning for the forthcoming 2024-2027 strategic plan launch which will ensure the continuance and expansion of adequate and effective policing initiatives to support our rapidly growing city.

Our Service's first four-year multi-year budget was developed and unanimously supported by our Board and City Council. Working with internal and external partners, this multi-year budget allows our Service to remain on track to ensure appropriate levels of service now and into the future in a way that is safe and sustainable for our members and our citizens.

As part of our community policing priority, 2023 saw a considerable increase in our documented proactive community engagements. This achievement was accomplished despite 2023's extraordinary service demands which included a record number of calls for service and saw our members conducting an unprecedented number of homicide and other major investigations.

Our Citizens' Police Academy was delivered multiple times throughout the year to over 70 adult and youth participants. Our Youth Engagement Program (YEP) saw a record number of participants. We continued our Service's Crime Prevention Through Environmental Design (CPTED) program, and our Pre-Charge Diversion Program which focuses on restorative justice and using relationships with community organizations to address minor offences rather than having persons enter the criminal justice system.

In addition to hosting our 2023 GPS Family Fun Day which saw over 400 community members visit our Headquarters, in 2023 there were over 45 community events that the Service organized, facilitated, or participated in including: Special Olympics Torch Run; Coffee with a Cop; Dairy Queen ice cream ticket campaign; Tim Hortons Camp Day; Cops and Kids Christmas Campaign; and Sirens for Life. Additionally, 2023 saw the inauguration of our Certificate of Appreciation Program where the Service recognizes members of our community who go above and beyond to keep our city safe and enjoyable for all.

In 2023, our Service actively focused on exploring new ways of engaging our community through our Media Unit. As a result, we saw an increase in views of daily media releases on our website to approximately 1,400+/day. Our Media Unit also disseminated more than 1,100 posts on our social media channels to keep the community informed daily about the work of the Guelph Police Service, to share safety tips, and to promote the work of our community partners.

Our Downtown Supplemental Staffing Initiative was launched in April 2023. This initiative saw dedicated officers on foot and bike patrol in the downtown core resulting in a much greater presence and engagement with our Downtown Community.

Unfortunately, in 2023 our Service and our community were reminded that we are not immune from the types and severity of crimes being committed in larger urban centres and the world. In 2023, our City saw four homicides and we continued to experience a very concerning trend of firearms and other weapons being used in our city. The presence of these illegal weapons jeopardizes the safety of our citizens and our members. Of significant concern was the disturbing presence of human trafficking and intimate partner violence related crimes. In addition, we continue to observe troubling numbers of cyber-enabled crimes that victimize our most vulnerable residents in the areas of child pornography, ransomware and frauds, and internet related scams.


As a result of the multi-year budget approved by our Board and Council, we have a well-established plan to increase the much-needed supports to address these increasingly present and serious crimes which are having devastating impacts on victims.

On behalf of the Board and the Executive, we wish to extend our personal appreciation to our officers and civilian staff, our community partners, and the citizens of Guelph for their continued support. 2023 saw both successes and challenges. As an organization, we remain steadfast in our commitment to work with our community to make Guelph the safest and healthiest city possible.

Community Engagement Initiatives

- **Citizens Police Academy**
Our interactive sessions aim to enhance public safety through education while building trust and understanding between the police Service and our community. Topics include traffic enforcement, frauds, forensics, and emergency response.
- **Youth Engagement Program**
Our Youth Engagement Program is designed for students in grades 10 to 12+ to learn about policing in an interactive and informative way. Participants learn about our recruiting and training, forensic identification, traffic services, tactical response, drug, and canine units while earning 20 community service hours.
- **Crime Prevention Through Environmental Design (CPTED)**
The CPTED Program affords members of the public the opportunity to have an officer come to their home or business and learn ways to make their property more secure.
- **Pre-Charge Diversion Program**
This program focuses on restorative justice and using relationships with community organizations to address minor offences rather than having persons enter the criminal justice system.
- **GPS May Family Fun Day**
Over 400 community members engaged with officers and civilian members of our Service at Headquarters and were introduced to our many different units including our K-9 team.



■ **Community Participations**

In 2023, the Service organized, facilitated, or participated in over 45 community events including: the Special Olympics Torch Run; our weekly Coffee With a Cop initiative; the Dairy Queen Ice Cream Ticket campaign; the Tim Horton's Camp Day; the Cops and Kids Christmas Campaign; the Sirens for Life Blood Donor Campaign; Guelph Wellington Multicultural Festival.

■ **Certificate of Appreciation Program**

Launched in 2023 to recognize members of our community who go above and beyond to keep our city safe and enjoyable.

■ **Community engagement focus via our Media Unit**

In 2023 our Service explored new ways of sharing daily media releases resulting in an increase of views on our website to approximately 1,400+/day. Additionally, more than 1,100 posts on our social media channels kept the community informed daily about the work of our Service.

■ **Downtown Supplemental Staffing Initiative**

A visible foot/ bike patrol specific to the downtown was initiated in 2023 running from April to September. As a result, there was a significant increase in the number of community contact and proactive patrol occurrences for that time period. This program was well received by our citizens and has led to increased resources for the downtown.

Internal Initiatives

■ **Women's Integrated Support Network-Immigration Services Mentorship Program**

Our Service's Women's Integrated Support Network partnered with Immigrant Services Guelph-Wellington in its one on one mentoring program and provided participants information to assist newcomers to our City.

■ **Our Service also engaged in a number of Wellness initiatives for the benefit of our members.**



2023 Provincial Grants

2023 was a very successful year for our Service in securing provincial grant funding to support initiatives which would have otherwise been impossible without incurring additional costs for our community.

We acknowledge the support of the Government of Ontario for providing these grants.

● **Victim Support Grant**

to enhance capacity to support victims and survivors of intimate partner/domestic violence, human trafficking, and child exploitation through increased collaboration with local organizations and communities.

● **Closed-Circuit Television Grant**

to deter criminal activity and improve police investigations and public safety in our community.

● **Preventing Auto Theft Grant**

to enhance the Break, Enter and Auto Theft Team with additional equipment and personnel.

● **Mobile Crisis Response Team Enhancement Grant**

to increase coverage and service hours for the existing Integrated Mobile Police and Crisis Team (IMPACT) program.

● **Next Generation 9-1-1**

to support the transition to a new digital 9-1-1 platform as mandated by the Canadian Radio-television, and Telecommunications Commission (CRTC).






OTHER CRIMINAL CODE VIOLATIONS



*graph represents selected categories and is not a total accounting of all other criminal code violations




Controlled Drugs and Substances Act & Cannabis Act




Human Trafficking - Number of Calls and Related Charges Laid

Annual Use of Force

When an officer has displayed or applied force or utilized a force option as defined by regulation, the officer must complete and submit an electronic Use of Force Report.

Use of Force Report are submitted when:

- A handgun is drawn in the presence of a member of the public (excludes a member of a police service who is on duty), points a firearm at a person or discharges a firearm.
- A member uses a weapon other than a firearm on another person.
- A member uses physical force on another person, not in relation to training, that results in an injury requiring medical attention; and
- When a member deploys a Conducted Energy Weapon (CEW) on a person or an animal or displays the CEW in the Demonstrated Force Presence Mode.

A Provincial Use of Force Report is delivered by the Service to the Ministry Community Safety and Correctional Services annually.

The Guelph Police received 84,333 calls for service in 2023. Guelph Police officers attended to 107 incidents where either one or more levels of force were required to bring the situation to a successful resolution. Members of the Guelph Police Service used 184 varying Use of Force options during these 107 incidents. Based on the province's seven (7) race categories, 141 subjects involved were identified as follows: Black 14, East/Southeast Asian 5, Indigenous 2, Latino 1, Middle Eastern 5, South Asian 1, and White 113.

All Use of Force reports have been reviewed. Officers are trained to assess each situation and respond with the most appropriate use of force option considering officer safety, public safety, and subject safety.

Guelph Police officers, on a very regular basis, are faced with incidents of a serious and potentially dangerous nature. By providing multiple Use of Force options to our officers, we allow choices in how to deal with ever-changing circumstances. Officers can select and transition between their Use of Force options thereby achieving the most effective outcomes. Our officers continue to demonstrate that common sense, good judgment, and effective training are the key to our success in policing the City of Guelph.



Annual Use of Force

Annual Use of Force

PERCEIVED SUBJECT RACE:

As of January 1, 2020, under the Anti-Racism Act, police services are required to collect data on the perceived race of those subjects involved in reportable use of force incidents. All information gathered is used to identify, monitor, and address potential racial bias or profiling. The reporting requirements include identifying the perceived race of the subject at the time that force was applied. Race groups are categorized by the Ministry and are divided into seven groups: Black, East/Southeast Asian, Indigenous, Latino, Middle Eastern, South Asian, and White.



In all reported incidents, 75.2% of subjects reside locally, and 24.8% reside outside of jurisdiction.

In 2022, all levels of force used during an incident were reported, where previously, when a use of force incident was reported, only the highest level of force used was reported. For example, in a scenario where a firearm was both drawn and pointed in one incident, prior to 2022, only one level of would be reported for the incident (for the firearm pointed, the highest level of force). In 2022 only, this scenario would result in two use of force levels of force being reported for the incident, one for the firearm drawn and one for the firearm pointed.
